

# District 8

## Ticket Terms & Conditions

THE POSSESSION OF A DISTRICT 8 TICKET OR WRISTBAND SHALL CONSTITUTE AN ACCEPTANCE BY THE HOLDER OF THE TERMS, CONDITIONS AND ADVICE DETAILED BELOW AND IMPLIES AN UNDERTAKING ON THE PART OF THE HOLDER TO ACCEPT THEM.

The original purchaser of the ticket(s) must be present at the time of redemption and will be required to have photographic ID (a valid passport or drivers license) and the bank card they made the purchase with.

Tickets cannot be exchanged, transferred or refunded after purchase unless the event is cancelled or postponed and fall within our fair refund policy.

1. These conditions are to be read together with all other statements and or directives either shown on the ticket or displayed on the premises.
2. In the event of a breach of this contract by the promoter, the promoter shall not be liable for any loss, damage, cost or expense arising out of the breach, which was not reasonably foreseeable by the promoter at the date of this contract.
3. The promoter reserves the right to refuse admission to the holder if in the reasonable opinion of the promoter or their representatives; admission of the holder might be a risk to the safety of the audience and/or the holder and/or affect the enjoyment of the audience and/or the running of the venue. **All persons entering the venue site may be searched. Strictly NO illegal substances or 'Legal Highs' will be permitted into the site. Possession of either may lead to your ejection from the venue and possible prosecution.**
4. NO alcohol is permitted to be taken into the venue during the Alcohol license hours ( till midnight every night) but you are permitted to take it into the campsite if you have a weekend camping ticket/wristband.
5. Private sound systems, illegal substances, legal highs, glass, fireworks, flares, laser pens, and any other item which the organisers deem unsuitable or inappropriate will not be permitted into the venue site.
6. Please respect the venue and use the bins provided.
7. If you have any disabled access requirements please email [info@archetype.ie](mailto:info@archetype.ie) with at least one week in advance if possible. Access to facilities is subject to availability and not guaranteed. Anyone turning up on the day without making prior arrangements may not be able to access our facilities if they are full to capacity.
8. No animals will be admitted to the venue site, except guide and hearing dog.
9. District 8 is not suitable for young children. Age restriction is 18 years +.
10. If you look under 21 please do not be offended if we ask you for proof of age when you buy alcohol. Please bring proof of ID to show you are over 18. District 8 operates the 'Challenge 21' policy.
11. Official merchandise is only venue merchandise on sale inside the venue site. Do not purchase goods from unofficial vendors.
12. Strictly no trading is allowed inside the venue site without written permission from the venue.
13. No audio or video recorders, professional photographic equipment will be permitted in the venue site.
14. Whilst every effort is made to ensure the full, advertised bill performs this ticket is for an event and not a specific artist/band. District 8 reserves the right to change the bill or running time without prior notice and no refunds will be processed due to artist bill change /cancellation

15. In the event of cancellation of the venue by the promoter, their responsibility for refund is limited to the face value of the ticket only.
16. **Under no circumstances will duplicate tickets/ wristbands be issued should you lose or damage them.** Keep your wristband and tickets safe. District 8 tickets/wristbands remain the property of the Promoter until payment is received in full. Resale of tickets/wristbands is prohibited. You may not resell or transfer this ticket/wristband if you are selling or transferring in the course of business where we reasonably believe you to be doing so. It is strictly prohibited to attempt to resell a ticket/wristband within the venue site under any circumstances.
17. District 8 tickets/ wristbands may not be used for competitions or promotions without written permission from the promoter. This includes official District 8 sponsors and media partners.
18. Ticket/wristband holders consent to photography & filming/sound recording of the event as members of the audience, which may be used for promotional purposes.
19. Please note there are restricted capacities within all tented structures, once they reach their maximum capacities there will be no further admissions. You are not guaranteed admission to these areas.
20. It is against the law to smoke in enclosed spaces, please observe the signage around the venue site.
21. The promoters reserve the right to implement any restrictions/conditions deemed necessary before and during the event to ensure the safe management of the venue site.
22. The promoters reserve the right to amend the terms and conditions of this ticket in accordance with any new laws, legislation or internal company policies.
